Overview

As a Plumber you will maintain, install and operate building services equipment and systems. This includes all internal/external reticulated pipe work.

Plumbers work in either summer or winter jobs; shorter winters may also be an option. Plumbers work at all three Antarctic stations as well as at Macquarie Island.

The Job

As a Plumber you will be required to undertake some or all the following:

- Maintain, install and operate the following building services equipment/systems:
 - o Reticulated heating hot water and associated pumping systems;
 - o Reticulated potable water and associated pumping systems;
 - Reticulated fire services water and associated pumping systems;
 - Air handling plant, including ventilation and exhaust systems;
 - Sewerage treatment plant and associated pumping equipment;
 - High temperature incineration plant;
 - Fuel systems repair and maintenance;
 - Kitchen equipment and all LPG installations, including field huts;
 - Water production plant, including melt bell or reverse osmosis management; and
 - Medical gases and sterilization equipment.
- Prepare and submit monthly and annual reports.
- Collaborate and report to station Trade Supervisor and Kingston Infrastructure team.
- Operate a computerised maintenance management system.

- Maintain the plumbing stock inventory, and coordinate the annual reorder of spare parts, materials and equipment.
- Assist science programs where necessary.
- Winter plumbers are required to carry a mobile device and-participate in an on-call roster responding to out-of-hours-alarms generated by critical plant and equipment.
- The AAD is committed to providing a safe place of work, safe systems of work and a culture in which care for one another's safety and wellbeing is central to the way we do things. Having stated this, you are going to an extreme workplace. The consequences of you failing to understand your responsibilities can be catastrophic. It is therefore incumbent on all expeditioners to understand and implement the AADs Work Health Safety Commitment Statement and the AAD Safety Behaviours Framework.

As a proactive and positive member of the community you will:

- Maintain a personal and practical commitment to AAD policies and standard operating procedures (including work, health and safety and environmental policies). Training and guidance in regard to all responsibilities relevant to your position will be provided.
- Be rostered to perform duties to support the community life of the expedition, such as general kitchen duties, garbage clearance, general cleaning duties, and assisting other expedition members with official programs, to ensure an equitable contribution.
- Work in areas outside of your primary role, for example, providing assistance to other areas or science projects, or participating in general labouring tasks such as clearing snow or handling cargo.

What we are looking for

<u>Essential</u>

You can only be selected for this role if you have these essential skills and licences.

Qualifications/licences (provide copies in your application):

- A suitable trade certificate/apprenticeship in Plumbing or Mechanical Services with current registration to conduct work within Australia
- 3 years post trade experience in industry_as a minimum
- A White Card (issued after May 2009), or the ability to attain prior to commencement
- A current, unrestricted "C" class (manual) Australian driver's licence
- Valid passport when travelling to the Antarctic or sub-antarctic. The expiry date of the passport (and any relevant visa) must be at least 6 months beyond the planned end date of your intended stay in the Antarctic or sub-antarctic.
- A current statement of attainment in the following units of first aid, or the ability to attain prior to commencement:
 - Provide First Aid (HLTAID0011) must be valid for at least 18 months beyond the date of AAD commencement.
 - Provide CPR (HLTAID009) must be valid for at least 6 months beyond the date of AAD commencement.

<u>Desirable</u>

These are not essential to the role, however, to be suitable you will need to have at least some of these. We encourage you to apply even if you do not have all the desirable_requirements.

Recent hands-on experience (within the last 5 years):

- Maintenance of Pumps and Pump systems (centrifugal pumps, submersible pumps, positive displacement pumps);
- Knowledge in the operation and maintenance of air handling plant;
- Knowledge in the use and operation of pressure and temperature controls (heating hot water and ventilation systems);
- LPG systems and maintenance of commercial kitchen equipment;
- Maintenance and installation of fire sprinkler systems;
- Experience in operation and maintaining sewage treatment plants Rotating Biological Contactor or Membrane Bioreactor;
- Maintaining medical gas systems;
- Corrosion treatment of heated water systems;
- Installation and maintenance of heating hot water systems; including but not limited to panel radiators, heat exchangers, air water coils, 3-2 way motorised valves;
- Experience working on packaged oil-fired boiler systems;
- Thermostatic mixing valve certification Commission and maintain hot and heated water temperature control devices (CPCPWT4023A or CPCPWT4023);
- Backflow prevention device certification CPCPWT4022A Commission and maintain backflow prevention devices or equivalent;
- Current Australian gas-fitting certification/-license-incorporating LPG appliances;
- Operating and maintaining a potable water production plant (reverse osmosis);
- Metal fabrication/electric welding/sheet metal work;
- HDPE welding;
- Operation of a computerised maintenance management system;
- Technical reporting/writing reports.

Additional

Should your application be successful, it is useful to have some understanding of any additional licences/accreditation you have, such as:

<u>Personal Qualities</u> - The Australian Antarctic Division assesses the personal qualities required to successfully live and work in an isolated Antarctic or sub Antarctic community. Successful candidates need to demonstrate the personal qualities criteria detailed <u>here</u>. This will be assessed during the selection process.

Eligibility and other requirements

<u>**Citizenship</u>** – In accordance with the PS Act 1999, APS employees are required to be Australian citizens. Persons who are not Australian citizens will generally only be considered where there are no suitable Australian applicants, with next considerations being Australian residents with work rights and New Zealand citizens</u>

<u>Security Clearance</u> - This position does not require a security clearance.

<u>Pre-employment Check</u> - Your suitability for employment will be assessed through a preemployment screening process. This process includes a requirement to undergo and satisfy a National Police Check, referee checks, character clearance and a pre-employment medical and psychological adaptability assessment, specified mandatory qualification(s) validation and a probation period.

If required, this may include comprehensive drug screening for compliance to undertake Safety Sensitive Aviation Activities (SSAA).

Requirement to be vaccinated under public health orders

It may be a condition of your employment that:

- 1. if you are required to be vaccinated against COVID-19 under an applicable Australian law; or
- 2. if the department is unable under an applicable Australian law to permit you to attend for work (ie outside of your usual place of residence) unless you are vaccinated against COVID-19,

Work Health and Safety Obligations
